Notice of discontinuation and replacement of ÄKTA ready™ 450 chromatography system version

Dear Customer,

The current ÄKTA ready™ 450 system will be discontinued and replaced with an updated system version.

The compatibility with the ÄKTA ready™ 450 flow kits is unaffected of this update.

Cytiva will sell the last systems of the current ÄKTA ready™ 450 until they are out of stock. This is expected to occur by the end of 2025. The updated version is now available for ordering. The major changes are use of Rockwell PLC and EtherNet/IP communication protocol. The change does not affect the flow kits or use of the flow kits.

We know you value high-quality products and expert technical support for your chromatography development and manufacturing needs. The new system includes new features and functionality (interactive process picture and an improved UV sensor among other things) but will operate similarly to the current system for easy replacement or expansion of process lines. It is controlled by UNICORN™ control software 7.11 or later versions. Cytiva webpage will provide more information about the new system by the end of 2025. We'll continue to deliver systems to the best of our capability in the meantime. Aging components and security of supply of parts required for manufacturing, service, and support of ÄKTA ready™ 450 chromatography systems have contributed to this decision.

Ongoing service for installed systems

We will continue to offer repair services and technical and application support for minimum 10 years after this discontinuation announcement, in accordance with our discontinuation policy for BioProcess™ hardware (Policy for end of service support for BioProcess™ hardware, 25 October 2023).

Service agreements will be available, with an expiration date of 1 January 2036 at the latest. After that, our service and support will operate on a best-effort basis, depending on the availability of parts. We will continuously communicate updates, availability, and our plans for product replacement through our regional representatives.
