Notice of retirement of Palltronic Flowstar LGR instrument

Dear Valued Customer.

You are receiving this notification as a user of the Palltronic Flowstar LGR instrument.

Concurrent with the launch of the Flowstar V LGR instrument we have ceased manufacture and are no longer accepting orders for the Flowstar LGR instrument.

To support any new customer requests, we can supply Cytiva's Flowstar V LGR - a dual-function filter integrity and leak tester that enables pre-use detection of pinholes and non-integral junctions in biocontainer assemblies up to 200L.

As we are deeply committed to supporting the critical operations of our customers in the life sciences and biomanufacturing industries, and in keeping with our promise to support our customers of discontinued products for a minimum of 10 years, we will maintain service support of the Flowstar LGR instrument, until 1st Nov 2035. This service support includes calibration, spare parts and preventative maintenance.
